

**ORDINANCE NO. 400**

**AN ORDINANCE OF THE CITY OF CALIMESA  
AMENDING CALIMESA MUNICIPAL CODE  
SECTION 2.10.040 TO INCREASE CITY COUNCIL  
SALARY PURSUANT TO SENATE BILL 329**

**THE CALIMESA CITY COUNCIL DOES ORDAIN AS FOLLOWS:**

**Section 1.** Calimesa Municipal Code Section 2.10.040 concerning council member salary is hereby amended to read as follows:

“2.10.040 Compensation.

A. Each council member shall be entitled to a salary in the amount of \$700 per month. (Government Code Section 36516.)”

**Section 2.** Effective Date; Publication. This ordinance shall take effect 30 days after its final passage, and within 15 days after its passage, the City Clerk shall cause this ordinance or a summary hereof to be published and/or posted as required by law and by the City's ordinances and resolutions.
